ORDER GRANTING MOTION FOR EXTENSION OF TIME

On July 16, 2019, the Commission's Staff and Ameren Missouri jointly filed a motion requesting additional time to file the *List of Issues, List and Order of Witnesses, and Statements of Position*. They ask to extend the filing dates of the *List of Issues, List and Order of Witnesses* from July 16, 2019, to July 19, 2019, and the *Statements of Position* from July 17, 2019, to July 22, 2019. Staff and Ameren Missouri state that they are engaged in settlement discussions and need additional time to determine if the issues can be resolved or narrowed. The Commission will extend the time sufficient to allow the Commission time to prepare for the hearing after the filings.

THE COMMISSION ORDERS THAT:

1. No later than July 18, 2019, the parties shall jointly file the *List of Issues, List and Order of Witnesses*.
2. No later than July 19, 2019, the parties shall jointly file their *Statements of Position*.

3. This order shall be effective when issued.
