ORDER DIRECTING STAFF TO FILE A DRAFT RULE

The Commission opened this file on July 11, 2018, at the request of the Commission's Staff, to assist Staff in its review and consideration of new and existing rules regarding the treatment of affiliate transactions and HVAC (heating, ventilating, and air conditioning) affiliate transactions by and among electrical corporations, gas corporations, heating companies, water corporations with more than 8,000 customer, and sewer corporations with more than 8,000 customers. Since that time, Staff has collected comments from stakeholders about a draft rule it has prepared.

On June 4, 2019, Public Counsel filed a petition asking the Commission to promulgate an affiliate transaction rule applicable to water and sewer corporations, expressing concern about Staff's pace of progress in drafting such rules. The Commission has denied Public Counsel's rulemaking petition, but will establish a deadline for Staff to file a draft rule for the Commission's consideration.

THE COMMISSION ORDERS THAT:

- 1. No later than September 16, 2019, Staff shall file a draft rule regarding the treatment of affiliate transactions and HVAC (heating, ventilating, and air conditioning) affiliate transactions by and among electrical corporations, gas corporations, heating companies, water corporations with more than 8,000 customer, and sewer corporations with more than 8,000 customers.
 - 2. This order shall be effective when issued.
