**ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM  
RIDER RATE ADJUSTMENT TARIFF**

Issue Date: July 15, 2019

Effective Date: August 1, 2019

On May 31, 2019, Kansas City Power & Light Company (KCP&L) filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) rider. The submitted tariff sheet carries an effective date of August 1, 2019. The Commission issued notice of the filing, set an intervention deadline, and directed the Commission's Staff to submit a recommendation. Staff submitted its recommendation on July 1, 2019, advising the Commission to approve KCP&L's tariff. No party filed a response to Staff's recommendation.

Commission Rules 4 CSR 240-20.093(4) and 4 CSR 240-3.163(8) require KCP&L to make semi-annual adjustments of its DSIM rates to reflect the amount of revenue that has been over- or under-collected. The proposed tariff sheet increases the current residential DSIM Rider rate from \$0.00017 per kWh to \$0.00362 per kWh for residential customers, and decreases the non-residential DSIM Rider rate from \$0.00274 per kWh to \$0.00252 per kWh for non-residential customers. KCP&L's requested adjustment would increase the

bill of a residential customer by \$3.45 for every 1,000 kWhs used, and would decrease a non-residential customer's bill by \$0.22 for every 1,000 kWhs used.

Staff also notes that this DSIM filing includes KCP&L's MEEIA Cycle 2 extension through December 31, 2019, in accordance with a stipulation and agreement filed in File No. EO-2019-0132.

Commission's Rule 4 CSR 240-20.093(4) regarding adjustment of DSIM rates between general rate proceedings states that if the proposed adjustments are in accordance with the rule, Section 393.1075, RSMo, and the previously-approved DSIM, the Commission shall issue an order approving the tariff sheets, and the adjustments shall take effect sixty days after the tariff is filed. The Commission has reviewed KCP&L's tariff filings and Staff's recommendation and memorandum, and finds that the proposed tariff sheet implementing the DSIM rate adjustment is in compliance with KCP&L's existing DSIM tariffs and with all applicable statutes and regulations. The Commission will approve KCP&L's tariff.

**THE COMMISSION ORDERS THAT:**

1. Kansas City Power & Light Company's tariff filing, assigned Tariff Tracking No. JE-2019-0216, is approved to be effective August 1, 2019, as an interim rate adjustment, subject to prudence review. The tariff sheet approved is:


