**ORDER ESTABLISHING TIME TO RESPOND TO APPLICATION TO INTERVENE OF
DOGWOOD ENERGY**

The Commission opened this file as a working case to facilitate Staff's investigation of the self-commit and self-scheduling practices of Missouri's investor-owned electric utilities in their respective RTO energy markets. The Commission's order opening this file directed the investor-owned electric utilities to provide certain generation and self-commitment data to the Commission's Staff by July 8, 2019. The Commission allowed for responses and further submissions to be made by any stakeholder by July 17. That deadline has since been extended until July 23.

Some of the responses filed by the investor-owned electric utilities were filed as confidential, meaning non-parties to this case are unable to view the confidential data and thus are unable to fully respond. In order to view the confidential data, Dogwood Energy, LLC applied to intervene on July 17. The Commission will shorten the time allowed to respond to those applications to intervene so that the Commission will be able to rule on those applications in time to allow Dogwood an opportunity to view the confidential data before filing a response.

THE COMMISSION ORDERS THAT:

1. Any stakeholder wishing to respond to the application to intervene filed by Dogwood Energy, LLC, shall do so no later than July 18, 2019.
2. This order shall be effective when issued.
