## NOTICE OF AGREEMENT

COMES NOW Southern Union Company d/b/a Missouri Gas Energy (MGE), and hereby notifies the Missouri Public Service Commission (Commission) of MGE's Agreement with the Staff Recommendation, as corrected:

- 1. On September 10, 2012, the Staff of the Commission (Staff) filed a Staff Recommendation.
- 2. The Staff Recommendation suggested that the Commission issue an order that:
  - Rejects MGE's ISRS tariff sheet filing (JG-2013-0028) filed by MGE on July 11, 2012;
  - Approves the Staff's determination of the ISRS surcharge revenue in the incremental amount of annual pre-tax revenues of \$823,284; and,
  - Authorizes MGE to file an ISRS rate for each customer class as reflected in Appendix B that generates a total of \$4,601,712 annually.
- 3. Subsequently, on September 14, 2012, Staff filed a Corrected Appendix B, in order to reflect the most current customer count information.
- 4. Having reviewed the September 10, 2012 Staff Recommendation, and the September 14, 2012 Corrected Appendix B, MGE hereby notifies the Commission that it accepts, and is in agreement with, the above

recommendations and rates, as corrected.<sup>1</sup> MGE therefore asks that the Commission issue an order as requested by the Staff.

WHEREFORE, MGE respectfully requests that the Commission consider this Notice of Agreement and, thereafter, issue an order consistent with the Staff Recommendation, as corrected.
