**ORDER FURTHER EXTENDING TIME TO FILE STAFF RECOMMENDATION**

On June 13, 2019, Union Electric Company d/b/a Ameren Missouri filed an Application and Request for Waiver, requesting that the Commission authorize it to sell an electric transformer to SSM HEALTH, INC. d/b/a SSM Health Saint Louis University Hospital. Because SSM Health is planning construction involving the transformer, Ameren Missouri asked the Commission for expedited approval of the transfer.

In an effort to comply with Ameren Missouri's request for expedited consideration, the Commission directed its Staff to file a recommendation by July 3, and later extended that due date until July 23. On July 22, Staff filed a motion explaining its inability to file a recommendation within the established time, and requesting to be allowed until August 2 to file its recommendation. The motion represents that Ameren Missouri does not oppose the request for additional time.

The Commission will grant Staff's request for additional time and encourages Staff to file its recommendation as soon as possible.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a recommendation regarding Ameren Missouri's Application and Request for Waiver no later than August 2, 2019.
2. Any other party wishing to file a recommendation regarding Ameren Missouri's Application and Request for Waiver, or that wishes to respond to Staff's recommendation, shall do so no later than two business days after Staff files its recommendation.
3. This order shall be effective when issued.
