**JOINT MOTION TO AMEND PROCEDURAL SCHEDULE**

**COME NOW** Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), Staff of the Missouri Public Service Commission (“Staff” and “Commission,” respectively), the Office of Public Counsel (“OPC”), Renew Missouri Advocates d/b/a Renew Missouri (“Renew Missouri”), Natural Resources Defense Council (“NRDC”), and Midwest Energy Consumers Group (“MECG”),<sup>1</sup> collectively, the “Parties,” and jointly propose to amend the procedural schedule.

1.       On October 4, 2023, the Missouri Public Service Commission adopted a procedural schedule in this docket. Since the Commission adopted the procedural schedule, Ameren Missouri requested approval of a Financing Order Allowing Issuance of Securitized Utility Tariff Bonds in File No. EF-2024-0021. On January 3, 2024, the parties in EF-2024-0021 filed a procedural schedule that will allow the Commission to review that request within the 120-day statutory deadline.

2.       Many of the parties in File No. EF-2024-0021 are also Parties to this proceeding. In order to eliminate the overlap of schedules in the two proceedings, the Parties agreed to amend this schedule. The resulting proposed amended procedural schedule is as follows:
