ORDER DIRECTING RESPONSE

Missouri Public Service, a division of UtiliCorp United Inc., (MPS) filed a proposed tariff with the Commission on July 20, 2000. MPS' tariff carries an effective date of September 1, 2000. On August 1, 2000, the Office of the Public Counsel (Public Counsel) filed a Motion to Suspend and Request for Establishment of Procedural Schedule and Hearing. On August 11, 2000, MPS and the Staff of the Commission (Staff) filed responses to Public Counsel's Motion in which they opposed Public Counsel's motion. On the same date, Missouri Purchasing Resource Center - Energy Consortium filed a application to intervene in support of the tariff. Subsequently, on August 21, 2000, Mountain Energy Corporation filed a Petition to Intervene that raised new questions about the tariff. In addition, on August 22, 2000, Public Counsel filed a reply to MPS' response.

Before making a decision on whether or not to suspend MPS' tariff, the Commission would like to have responses from MPS and Staff to the allegations raised in the pleadings filed by Mountain Energy Corporation and Public Counsel. The time remaining before the effective date of the tariff is short and therefore a prompt response will be required.

IT IS THEREFORE ORDERED:

- 1. That, no later than 3:00 p.m. on August 28, 2000, UtiliCorp United Inc. d/b/a Missouri Public Service shall file its response to the Petition of Mountain Energy Corporation to Intervene and to Public Counsel's Reply to UtiliCorp's Response to OPC Motion to Suspend.
- 2. That, no later than 3:00 p.m. on August 28, 2000, the Staff of the Commission shall file its response to the Petition of Mountain Energy Corporation to Intervene and to Public Counsel's Reply to UtiliCorp's Response to OPC Motion to Suspend.
 - 3. That this order shall become effective on August 28, 2000.
