**ORDER GRANTING LEAVE TO FILE SUPPLEMENTAL
TESTIMONY OF LENA M. MANTLE**

On July 17, 2019,¹ the Office of Public Counsel (“OPC”) filed a *Motion for Leave to File Supplemental Rebuttal Testimony of Lena M. Mantle* (“motion”) and tendered the proposed testimony. On July 19, the Commission set a July 22 deadline for responding to the motion. No one filed a response to OPC’s motion.² The Commission will grant the motion.

THE COMMISSION ORDERS THAT:

1. OPC’s *Motion for Leave to File Supplemental Rebuttal Testimony of Lena M. Mantle* is granted.
2. Staff’s *Cross-Rebuttal Testimony of Kory J. Boustead*, filed July 22, 2019 is deemed responsive to Ms. Mantle’s supplemental rebuttal testimony regardless of filing dates.
3. All deadlines set in the procedural schedule orders of March 22, 2019 shall remain in effect.

² On July 22, Staff filed the *Cross-Rebuttal Testimony of Kory J. Boustead*. (The Commission’s March 22 *Order Amending Procedural Schedule* had set July 22 as the deadline for cross-rebuttal.) Witness Boustead states its purpose is to respond to Ms. Mantle’s rebuttal testimony filed on June 6 and July 17, Page 1. The Commission infers that Staff thus accedes to OPC’s motion.

4. This order shall be effective when issued.

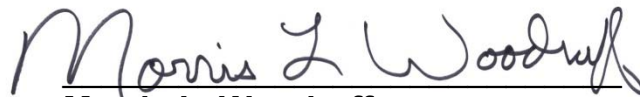
