NOTICE OF INTERVENTIONS GRANTED AT PROCEDURAL CONFERENCE AND CHANGE OF FILE CAPTION AND ORDER SETTING RESPONSE TIME AND DIRECTING FILING OF PROPOSED PROCEDURAL SCHEDULE

While on the record at the start of the procedural conference on July 24, 2019, the presiding officer granted the unopposed applications to intervene filed by the Missouri Department of Economic Development - Division of Energy, Missouri Industrial Energy Consumers, Natural Resources Defense Council, and Sierra Club. Those entities are now parties to this file.

Additionally, at the procedural conference, the presiding officer indicated she would amend the caption of File No. ER-2019-0335 to reflect that the original request is for a rate decrease rather than a rate increase.

The parties also indicated at the conference that they would file a proposed procedural schedule in this matter by August 1, 2019, along with any replies to the responses of Staff and the Office of the Public Counsel with regard to the proposed test year. The Commission will order these filings as set out below.

THE COMMISSION ORDERS THAT:

1. The requests for intervention of the Department of Economic Development – Division of Energy, the Natural Resources Defense Council, the Sierra Club, and the Missouri Industrial Energy Consumers are granted.
2. The caption of this file is amended to reflect that Union Electric Company, d/b/a Ameren Missouri requested a rate decrease.
3. Any replies to the responses of Staff and the Office of the Public Counsel regarding the proposed test year and true-up period for this case shall be filed no later than August 1, 2019.
4. The parties shall jointly or separately file a proposed procedural schedule no later than August 1, 2019.
