**ORDER ESTABLISHING TIME FOR STAFF TO FILE A  
RECOMMENDATION**

On July 25, 2019, Union Electric Company d/b/a Ameren Missouri filed a tariff that will permit some of its natural gas customers to choose a due date that would alter their billing cycles. The Commission previously granted Ameren Missouri a waiver from certain Commission rules to allow for the filing of this tariff.<sup>1</sup> The tariff, which purports to comply with the Commission’s order, carries an August 24, 2019 effective date.

The Commission will direct its Staff to file a recommendation regarding Ameren Missouri’s tariff. The Commission will also establish a date for the filing of any other response.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its recommendation regarding Union Electric Company d/b/a Ameren Missouri’s tariff no later than August 8, 2019.
2. Any other party wishing to respond to Union Electric Company d/b/a Ameren Missouri’s tariff shall do so no later than August 8, 2019.
3. This order shall be effective when issued.
