ORDER GRANTING, IN PART, PUBLIC COUNSEL'S APPLICATION FOR REHEARING

Issue Date: July 25, 2019 Effective Date: July 25, 2019

On May 3, 2019, the Commission issued a Report and Order in these cases with an effective date of May 14, 2019. On May 13, 2019, the Office of the Public Counsel (Public Counsel) filed a timely application for rehearing. Section 386.500, RSMo 2016, states that the Commission shall grant a rehearing if in its judgment there is sufficient reason to do so.

The arguments raised by Public Counsel in its request for rehearing were previously presented to the Commission and rejected with the exception of the matter of the net property tax value. Public Counsel argues that when Staff filed its revenue requirement calculations as ordered by the Commission, ¹ Staff incorrectly reverted to using the net property tax amounts updated through January 2019 that Spire Missouri

provided (\$2,598,507 and \$1,539,224 for Spire Missouri West and Spire Missouri East, respectively),² rather than net property tax amounts that would have reflected the property values with the plastic pipe disallowance. These net property tax amounts were carried through in Staff's subsequent updates to the revenue requirement calculations³ and were ultimately used in the final revenue requirement approved by the Commission. With regard to this limited issue, the Commission has determined that in its judgment a rehearing of its decision should be undertaken. Therefore, the *Motion for Rehearing or Reconsideration* will be granted for limited rehearing.

The Commission will direct the parties to meet for a procedural conference in order to propose a joint procedural schedule. The procedural schedule will provide for the simultaneous filing of direct testimony by Spire Missouri Inc. and Staff (and optionally by Public Counsel) regarding the methodology and calculations used to determine the amount of property tax. This testimony should provide sufficient information for the Commission to determine the total amount of plastic pipe disallowed, and the methodology and calculations used to determine that amount, along with evidentiary support for those amounts. The procedural schedule shall also provide for a date for rehearing where live rebuttal and cross-examination testimony will be heard.

Spire Missouri Inc., also filed a timely application for rehearing, which will be addressed by the Commission in a separate order at the conclusion of the rehearing. In accordance with Section 536.083, RSMo, this matter will be assigned to a different Regulatory Law Judge for the rehearing.
