ORDER SUSPENDING TARIFF SHEETS

Effective Date: July 25, 2019

On July 14, 2019, Spire Missouri Inc., filed applications and petitions with the Missouri Public Service Commission pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo. 2016, and Commission Rules 4 CSR 240-2.060, 2.080, and 3.265, requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges (ISRS).

The Commission issued notice of the applications and requested clarification of which tariff sheets filed with the applications Spire Missouri intended to take effect. On July 18, 2019, Spire Missouri filed its tariff revisions (Tariff Tracking Nos. YG-2020-0009 and YG-2020-0010). These tariff sheets bear an effective date of August 14, 2019.

Section 393.1015.2(3), RSMo, requires that the Commission act on the applications no later than 120 days after the petitions were filed. Therefore, the Commission must issue an order regarding the applications effective no later than November 12, 2019.¹ The Commission previously ordered a Staff recommendation to be

filed no later than September 13, 2019, and responses to that recommendation no later than September 19, 2019. In order for the Commission to have adequate time to consider Spire Missouri's applications, the proposed revised tariff sheets will be suspended.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed by Spire Missouri, Inc. for its Spire Missouri East service territory on July 18, 2019 (Tariff Tracking No. YG-2020-0009), is suspended until November 12, 2019.
2. The tariff sheet filed by Spire Missouri, Inc. for its Spire Missouri West service territory on July 18, 2019 (Tariff Tracking No. YG-2020-0010), is suspended until November 12, 2019.
3. This order shall be effective when issued.
