## ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE AND ESTABLISHING TIME FOR FILING RECOMMENDATIONS

Issue Date: July 24, 2019

Effective Date: July 25, 2019

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On July 24, 2019, Teleport Communications America, LLC, filed an application under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), Somos, to withhold certain numbering resources from Teleport. The numbering resources Teleport requested consist of 100 DID numbers in the format 660-XX4-72XX such that they integrate into the existing network in the Kansas City metro area. The numbering resources are needed to meet the needs of Saint Luke's Health System, at its Primary Care facility in the Clinton area.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, Somos.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, Somos.

2. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than August 5, 2019, with:

3. The Staff of the Commission shall file a recommendation regarding the application of Teleport or shall file a status report indicating when a recommendation will be filed, no later than August 23, 2019.

4. Any other party that wishes to file a recommendation regarding the application of Teleport, shall do so no later than August 23, 2019, and shall file its recommendation simultaneously with its application to intervene.

5. This order shall be effective when issued.


