**ORDER INVITING RESPONSES REGARDING THE COST TO COMPLY WITH
DRAFT RULE AMENDMENT**

The Commission opened this working case on September 27, 2017, at the request of its Staff, to gather information and facilitate discussion regarding the possible amendment of its rules related to cogeneration and net metering. After collecting comments from interested stakeholders, Staff has prepared a draft amendment, which it has been directed to submit to the Commission for consideration by August 30, 2019.¹

On July 29, 2019, Staff filed a copy of its draft amendment in this working file and asked the Commission to invite stakeholders to comment regarding the cost, if any, of implementing that draft amendment.

The Commission will invite written comments as requested by Staff.

¹ The Commission established that deadline for submission of a draft rule amendment in its *Order Denying Petition for Revision of Commission Rule 4 CSR 240-20.060*, issued on July 17, 2019 in File No. EX-2019-0378. Staff has been ordered to submit its draft rule in EX-2020-0006, a new file opened for that purpose, but the comments invited by this order should be submitted in this file.

1. Interested stakeholders are invited to submit written comments in this file by August 8, 2019, regarding the cost to comply with the draft amendment prepared by Staff.
2. This order shall be effective when issued.
