



**Notice of Appeal**  
**Brief Description of Case**  
**Missouri PSC case no. EA-2023-0017**

Grain Belt Express, LLC applied to the Missouri Public Service Commission (the “PSC”) to approve an amendment to its existing certificate of convenience and necessity (“CCN”) to permit the construction of an electrical transmission line through Monroe, Audrain and Callaway Counties. The case at issue was opened by the PSC as case no. EA-2023-0017. The Appellants Missouri Farm Bureau Federation, Missouri Soybean Association and Missouri Cattlemen’s Association moved to intervene as parties in the case, and were granted intervention by the PSC.

At the evidentiary hearing in case no. EA-2023-0017, the Appellants opposed Grain Belt Express, LLC’s application to amend its existing certificate of convenience and necessity (“CCN”) to permit the construction of an electrical transmission line through Monroe, Audrain and Callaway Counties. On October 12, 2023, the PSC granted Grain Belt Express, LLC’s application for amendment to its existing CCN in the PSC’s attached Report and Order of that date. On November 10, 2023, Appellants timely applied for rehearing in case no. EA-2023-0017. On December 7<sup>th</sup>, 2023, the PSC denied the Appellants application for rehearing.

**Issues Expected to Be Raised on Appeal**

**Missouri PSC case no. EA-2023-0017**

1. Whether Judge Dippel's (the PSC's hearing officer in case no. EA-2023-0017) refusal to allow relevant cross-examination of Grain Belt Express, LLC's witness Mark Repsher was unlawful, unreasonable and/or unjust.
2. Whether the PSC's finding of facts in its Report and Order regarding purported job creation by the Grain Belt project is unreasonable in that such finding was not supported by the testimony cited by the PSC as to Grain Belt Express, LLC's own witness Dr. David Loomis.






