## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE AND DIRECTING STAFF RECOMMENDATION

Issue Date: July 31, 2019 Effective Date: July 31, 2019

On July 31, 2019, Kansas City Power & Light Company ("KCPL") submitted an application containing its true-up filing for its Fuel Adjustment Clause ("FAC") to remedy an over-collection of \$839,014. KCPL requests that the Commission approve the over-collection amount and authorize KCPL to include that amount in the next accumulation period.

Pursuant to Commission Rule 4 CSR 240-20.090(9), the Commission's Staff shall submit a recommendation regarding the proposed true-up not later than 30 days after its filing. Within 60 days after receiving the proposed true-up, the Commission must: (1) issue an order approving the true-up; or (2) reject the proposed tariff sheet containing the true-up amount and suspend the timeline of the true-up to receive additional evidence or hold a hearing, if required. Consequently, the Commission will issue notice, set an intervention deadline, and direct its Staff to file a recommendation.

Commission Rule 4 CSR 240-20.090(17) provides that parties to the rate case in which the Commission established or continued KCPL's fuel adjustment clause are automatically parties to this tariff case, without the necessity of having to apply for intervention. Therefore, the Commission acknowledges that the parties to File No. ER-2019-0223 (the file in which

KCPL's FAC was most recently continued) are parties to this case, and will direct its Data Center to add those parties to the service list.

#### THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall serve a copy of this order upon the parties to File No. ER-2019-0223.
- 2. The Commission's Data Center shall add all parties to File No. ER-2019-0223 to the service list for this case.
- 3. Any person or entity wishing to intervene shall file an application to intervene no later than August 15, 2019.
- 4. The Staff of the Missouri Public Service Commission shall file a recommendation regarding its examination and analysis of Kansas City Power & Light Company's application no later than August 30, 2019.
- 5. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Kansas City Power & Light Company.
- 6. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of Kansas City Power & Light Company and to the news media serving the residents of the service territory of Kansas City Power & Light Company.

7. This order shall become effective when issued.
