THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon the parties to File No. ER-2019-0223.

2. The Commission's Data Center shall add all parties to File No. ER-2019-0223 to the service list for this case.

3. Any person or entity wishing to intervene shall file an application to intervene no later than August 15, 2019.

4. The Staff of the Missouri Public Service Commission shall file a recommendation regarding its examination and analysis of Kansas City Power & Light Company's application no later than August 30, 2019.

5. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of Kansas City Power & Light Company.

6. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of Kansas City Power & Light Company and to the news media serving the residents of the service territory of Kansas City Power & Light Company.

7. This order shall become effective when issued.


