KCP&L Greater Missouri Operations Company (GMO) filed an application on July 12, 2019, seeking authority to implement a special incremental load rate for a steel production facility in Sedalia, Missouri. Nucor Steel Sedalia, LLC, the owner of the steel production facility, filed a timely application to intervene on July 31, 2019. On August 1, Nucor filed a motion for expedited treatment asking that the Commission grant its application to intervene as soon as possible, and no later than August 6, so that it can begin to participate in the case. The application to intervene states that counsel for Nucor has consulted with counsel for all parties and represents that none object to Nucor's application to intervene. Based on the representation of counsel, the Commission will consider the application to intervene to be unopposed.

As a party to the contract that is the subject of this proceeding, Nucor has an interest that differs from that of the general public that may be adversely affected by the Commission's final order arising from this case. Further, allowing Nucor to intervene will serve the public interest. For those reasons, in accordance with Commission rule 4 CSR 240-2.075(3), the Commission will grant Nucor's application to intervene.

THE COMMISSION ORDERS THAT:

- 1. The Application to Intervene of Nucor Steel Sedalia, LLC, is granted.
- 2. This order shall be effective when issued.
