ORDER GRANTING APPLICATION TO INTERVENE

On July 14, 2019, Spire Missouri Inc., filed applications and petitions with the Missouri Public Service Commission pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo. 2016, and Commission Rules 4 CSR 240-2.060, 2.080, and 3.265, requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges (ISRS). The Commission issued notice of the applications and directed that any requests for intervention be filed no later than July 26, 2019, and any responses to those applications to intervene be filed no later than July 31, 2019. City of St. Joseph, Missouri, applied to intervene on July 26, 2019.

The deadline for responses to applications for intervention has passed and no response was filed. After considering the unopposed application to intervene, the Commission finds that allowing the City of St. Joseph, Missouri, to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of the City of St. Joseph, Missouri, is granted.
2. This order shall be effective when issued.
