Missouri-American Water Company (MAWC) filed the above-referenced tariffs on December 21, 2023. MAWC filed the tariffs to comply with the Commission’s December 21, 2023 *Order Approving Water and Sewer Infrastructure Rate Adjustments*. The tariffs bear effective dates of January 20, 2024.

On January 2, 2024, the Staff of the Commission filed a recommendation to approve the tariff sheets. No other responses were filed, and no party has objected.

Tracking No. JW-2024-0093 and JS-2024-0094 will be allowed to go into effect by operation of law on January 20, 2024.
