**RE: Notice of Change in Corporate Form and Name Change for Aristotle Unified Communications L.L.C.**

Dear Judge Dippell:

Pursuant to 20 CSR 4240-28.011 and 20 CSR 4240-31.015, Aristotle Unified Communications L.L.C. ("AUC"), by its attorneys, respectfully notifies the Missouri Public Service Commission ("Commission") of its change in name to Aristotle Unified Communications Inc. AUC currently holds authority to provide wireless cellular and interconnected Voice over Internet Protocol ("VoIP") services pursuant to Docket No. DA-2019-0159 and Docket No. DA-2019-0147. AUC was also designated as an eligible telecommunications carrier ("ETC") in Docket No. DA-2019-0147.

Effective October 5, 2023, AUC converted from an Arkansas limited liability company to an Arkansas corporation, and now operates under the name Aristotle Unified Communications Inc. Documentation from the State of Arkansas reflecting the conversion and name change is attached.


On December 22, 2023, pursuant to the procedures of the Missouri Secretary of State, AUC filed (1) Articles of Cancellation of a Foreign Limited Liability Company to withdraw Aristotle Unified Communications L.L.C.'s registration as a foreign limited liability company in the State of Missouri; and filed AUC's (2) Application for Certificate of Authority for a Foreign For-Profit Corporation. Accompanying this letter are the filed Articles of Cancellation, the Application for Certificate of Authority with approval documentation from the Missouri Secretary of State and Aristotle Unified Communications Inc.'s State of Missouri Certificate of Good Standing.

In accordance with 20 CSR 4240.28.011 and 31.015 pertaining to change in name for a certificate or registration, AUC states it has reviewed and updated its company contacts in EFIS.

In accordance with 20 CSR 4240-31.015, pertaining to a change in name for an ETC, AUC reaffirms its statements above regarding registration of the new name with the Missouri Secretary of State. AUC submits it will continue to comply with all applicable laws and rules with respect to its ETC designation.

AUC has no current ETC customers that will require notice of the name change. AUC respectfully requests the Commission update its records to reflect this change in corporate name.
