**NOTICE THAT CASE MAY BE DISCUSSED  
AT PRESENTATION IN EW-2023-0199**

Issue Date: January 12, 2024

On December 1, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") filed revised tariff sheets regarding a Solar Subscription Rider Tariff. Evergy also filed a *Notice of Tariff Revisions and Motion to Open New Docket*. On December 15, 2023, the Staff of the Commission filed a recommendation that the Commission reject the tariff filings, provide guidance regarding the treatment of Solar Subscription Program (SSP) participants with regard to time-based rate plans, and direct Evergy to file new tariff sheets. Staff also suggested that the Commission set an "on-the-record" to determine the kind of billing system changes Evergy would need to address the potential participation of SSP customers in the time-based rate plans offered by Evergy.

The Commission suspended the tariff sheets for 120 days until April 30, 2024. The Commission also convened a procedural conference to discuss what guidance Staff was suggesting the Commission give to the parties.

The Commission has scheduled a presentation in File No. EW-2023-0199. That file is a non-contested case established to provide a collaborative workshop for customer education and outreach regarding time-based rates for Evergy. Because the topics of the two files are closely aligned, the Commission provides this notice that questions and discussions related to File No. ET-2024-0182 may occur at that on-the-record presentation.

That presentation will be held on January 22, 2024, beginning at 10:00 a.m. in the Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The Governor Office Building meets accessibility standards required by the Americans with Disabilities Act.
