To whom this may concern. As I said before, I have no intention of allowing the Commission or the Regulatory Judge in my matter rule another unfair hearing for me.

I have had no fairness in this matter at all. I wasn't allowed to obtain discovery when I motioned for it from the Regulatory Judge. Basing on other cases within the last year from the RJ in my matter, he has an infamous history of cancelling evidentiary hearings last minute among parties.

Reference I-70 Mobile Home Park matter.

In addition, the payment agreement I submitted shows clear proof that Ameren failed to oblige by a payment agreement. In addition, paperwork submitted shows that Ameren failed to and discriminated against me in a medical hardship payment.

That being said, I was extorted into paying a balance that to date, Ameren has failed to provide nor did the Commission prove that the balance was actually owed. In fact, the Commission and RJ orders are identical statements without any visibility of proof owed, Ameren statements. I believe that the Regulatory Judge and the Commissioner are mere puppets to cover up the massive amount of fraud that they allow the utility provider to commit.

I spent 7 month of torture and being forced and extorted to pay a bill I didn't owe, to result in utility services being connected. Even after a massive number of complaints that were filed.

My due process was violated in nothing more than Kangaroo Court and thanks to a system of Kangaroo Court I spent seven months of nothing more than excuses and lies being pushed upon me by a Regulatory Judge and Commissioner.

If the Commission is up to a fair appeal, then sure. That allows me the discovery I requested from Ameren Missouri, then sure and a fair hearing, trial. Otherwise, I'm not going to invest my time or energy into wasting another half a year or 2/3rds of a year to listen to Kangaroo Court games.

I was extorted for a grand total of \$ [REDACTED], plus an \$ [REDACTED] inspection fee, along with another deposit added to my new account that I have no interest in the Commission or a RJ hearing, because at this point. Ameren has been allowed to practice policies they don't have. That doesn't include generators, gas, lodging etc expenses.

At this moment Ameren Missouri and the PSC have an outstanding debt that I will recourse in suit that is set for hearing on January 24, 2024, in Cole County, Courts.

Along with a newly filed Charge of Discrimination against Ameren Missouri that I just signed penned my signature on.

I'm going to seek recourse against each individual party in this matter and seek that every party is prosecuted to the highest extent of the law in this matter.

The PSC and Ameren Missouri can make satisfactory arrangements with my legal counsel on how to resolve this matter and repay the expenses that I came out of pocket for.

Otherwise, I have no desire to listen or hear another lie out of the Commission, RJ, Ameren or their legal counsel. They brought the matter upon themselves and shouldn't have lied.
