**ORDER DIRECTING FILING OF
CORRECTED STAFF RECOMMENDATION
AND COMPANY RESPONSE**

On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the North Oak Sewer District, Inc. (North Oak), which is providing sewer service in Warren County, Missouri. The Commission’s Staff (Staff) filed its Recommendation and Memorandum on January 12, 2024.

Staff’s Memorandum includes a header that references a different case number than the one captioned above. The Commission will direct Staff to file a corrected Memorandum to ensure accuracy for the Commission’s files.

Additionally, Staff’s Recommendation included at least two conditions specific to the needs of the North Oak system. The Commission will direct Confluence Rivers to respond.

1. Staff shall file a corrected Memorandum no later than January 18, 2024.
2. Confluence Rivers shall respond to Staff's Recommendation and Memorandum no later than January 22, 2024.
