ORDER APPROVING TARIFFS

Issue Date: January 16, 2024

Effective Date: January 29, 2024

On June 30, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced application. The Commission approved the application on December 13, 2023. In the order approving the application, the Commission ordered Confluence to file tariffs.

Confluence filed tariffs with Tracking Nos. JW-2024-0098 and JS-2024-0099 on January 5, 2024. The tariffs bear an effective date of February 4, 2024. However, because Confluence hopes to close on the Brussels Valley Estates assets on January 29, 2024, Confluence filed a Motion for Expedited Treatment. That motion asks the Commission to approve the tariffs no later than January 29, 2024.

The Commission's Staff filed a Recommendation on January 16, 2024. The Recommendation stated that the Commission should approve the tariffs. No other responses were received.

The Commission finds that the tariffs comply with the Commission's January 5, 2024 order. The Commission will approve the tariffs. The Commission further

finds that Confluence has demonstrated good cause for the tariffs to become effective on January 29, 2024.

THE COMMISSION ORDERS THAT:

1. The Motion for Expedited Treatment is granted.
2. The tariffs filed by Confluence on January 5, 2024, and assigned Tracking No. JW-2024-0098 and JS-2024-0099, are approved to become effective on January 29, 2024.
3. This order shall be effective January 29, 2024.
