REOUEST FOR ADDITIONAL TIME TO RESPOND TO STAFF RECOMMENDATION

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and requests additional time to respond to the *Staff Recommendation Regarding Union Electric's 2021-2022 Actual Cost Adjustment Filing* and its attached Memorandum, (collectively, "Staff Recommendation"). In support of this request, Ameren Missouri states as follows:

- 1. The *Staff Recommendation* was filed on December 12, 2023, and included a recommendation that the Company adjust its ACA account balances as well as five recommendations related to Ameren Missouri's Reliability Analysis and Gas Supply Planning. Those recommendations include evaluation of capacity needs based upon peak day supply needs; using meter read dates to determine month revenues; using the PGA and other indexes or modification of its tariffs to align with cash out practices; evaluating hedging strategies; and continue evaluation other hedging practices. Ameren Missouri will respond to each below.
- 2. On December 20, 2023, the Missouri Public Service Commission ("Commission") ordered Ameren Missouri to respond to the Staff Recommendation no later than January 17, 2024.
- 3. Ameren Missouri requests additional time to respond to the *Staff Recommendation*. The Company believes further discussion with Staff may assist in resolving a significant (in terms of cost) recommendation. Ameren Missouri has had initial conversations about this matter with Staff but requires further discussion to work through the issue.

- 4. Ameren Missouri requests an additional 60 days, until February 16, 2024, to file its response to the *Staff Recommendation*.
- 5. There is no rate change associated with this case and this delay does not prejudice Staff or any other party.

WHEREFORE, Ameren Missouri requests the Missouri Public Service Commission extend the due date for the Company's response and allow it to file its response by February 16, 2024.
