**ORDER DIRECTING COMPLAINANTS TO SHOW CAUSE  
WHY COMPLAINT SHOULD NOT BE DISMISSED**

On January 2, 2024, the Commission issued an order setting a procedural conference in this matter for January 17, 2024, at 10:00 a.m., to be conducted via WebEx telephone and video conference. Counsel for Union Electric Company d/b/a Ameren Missouri and counsel for the Staff of the Commission appeared for the procedural conference at the scheduled date and time. Complainants Dranel J. Clark and Aquilla Canada did not appear.

Per Commission Rule 20 CSR 4240-2.090(5), "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint . . . unless good cause for the failure to appear is shown." The Commission will order the Complainants to file a pleading showing cause as to why their complaint should not be dismissed.

**THE COMMISSION ORDERS THAT:**

1. Complainants Dranel J. Clark and Aquilla Canada shall file a pleading no later than January 31, 2024, showing cause why their complaint against Ameren Missouri should not be dismissed for failure to appear for the scheduled prehearing conference.

2. This order is effective when issued.
