ORDER GRANTING AN EXTENSION OF TIME TO RESPOND TO STAFF'S RECOMMENDATION

On December 12, 2023, The Staff of the Commission (Staff) filed its recommendation about Union Electric Company d/b/a Ameren Missouri's actual cost adjustment filing. The Commission set a deadline of January 17, 2024, for Ameren Missouri to respond to Staff's recommendation and for any other responses to Staff's recommendation.

On January 17, 2024, Ameren Missouri filed a request to extend the time for it to respond to Staff's recommendation. In support of its position, Ameren Missouri states that no rate change is associated with this case and this delay does not prejudice Staff or any other party.

The Commission will grant the motion for an extension.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri must file its response to Staff's recommendation no later than March 15, 2024.
2. Any replies to Ameren Missouri's response are due no later than March 28, 2024.
