**ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM
RIDER RATE ADJUSTMENT TARIFF**

Issue Date: January 18, 2024

Effective Date: February 1, 2024

On December 1, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a tariff sheet, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) Rider under the Missouri Energy Efficiency Investment Act (MEEIA). The tariff sheet filing was assigned Tracking No. JE-2024-0085, and carries an effective date of February 1, 2024.

The Commission issued notice of the filing, set an intervention deadline, and directed the Staff of the Commission (Staff) to submit a recommendation. On January 2, 2024, Staff recommended the Commission approve Evergy Missouri West's tariff sheet. No responses or objections were received to either Evergy Missouri West's filing or Staff's Recommendation.

Commission Rules 20 CSR 4240-20.093(4) and 20 CSR 4240-3.162(8) require Evergy Missouri West to make adjustments of its DSIM rates to reflect the amount of revenue that has been over- or under-collected. The proposed tariff sheet increases the current residential DSIM Rider rate from \$0.00224 per kWh to \$0.00359 per kWh for

residential customers. For a residential customer using 1,000 kWh, this change will increase the customer's bill by \$1.35 per month.

Non-residential customer impacts would be as follows:

Small General Service from \$0.00179 per kWh to \$0.00243;

Large General Service from \$0.00277 per kWh to \$0.00475; and

Large Power Service from \$0.00162 per kWh to \$0.00263.

For a non-residential customer using 1,000 kWh monthly, this would result in the following monthly billing changes:

Small General Service, a \$0.64 increase;

Large General Service, a \$1.98 increase; and

Large Power Service, a \$1.01 increase.

Commission Rule 20 CSR 4240-20.093(4), regarding adjustment of DSIM rates between general rate proceedings, states that if the proposed adjustments are in accordance with the rule, Section 393.1075, RSMo, and the previously-approved DSIM, the Commission shall issue an order approving the tariff within 60 days after the tariff is filed. The Commission has reviewed Evergy Missouri West's tariff sheet and Staff's Recommendation and finds that the proposed tariff sheet implementing the DSIM rate adjustment is in compliance with Evergy Missouri West's existing DSIM tariff and with all applicable statutes and regulations.

So that the tariff sheet will be effective on the date requested, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. Evergy Missouri West's revised tariff sheet, assigned Tracking No. JE-2024-0085, is approved to be effective February 1, 2024. The tariff sheet approved is:
