**ORDER GRANTING ADDITIONAL TIME
FOR RESPONSES TO DATA REQUESTS**

On August 1, 2019, the Lake Area Waste Water Association, Inc. (LAWWA) and the Missouri Water Association, Inc. (MWA) filed a request for additional time to respond to Data Requests issued to them by the applicant, Osage Utility Operating Company, Inc. (Osage). LAWWA and MWA stated that each received 31 Data Requests from Osage on July 19, 2019, and due to overlapping vacation schedules of LAWWA and MWA counsel and Kelly Goss, the person providing the necessary responses, LAWWA and MWA would be unable to respond by the due date of August 1, 2019. LAWWA and MWA indicated that they need an additional five days, until August 6, 2019, in which to respond. LAWWA and MWA also represented that Osage does not object to the extension of time.

The Commission will grant an additional five days for LAWWA and MWA to respond to the Data Requests issued to it by Osage.

THE COMMISSION ORDERS THAT:

1. The Request for Additional Time to Respond to Data Requests filed by Lake Area Waste Water Association, Inc., and the Missouri Water Association, Inc., is granted.
2. Lake Area Waste Water Association, Inc., and the Missouri Water Association, Inc., are granted until August 6, 2019, to answer the 31 Data Requests they received on July 19, 2019, issued to them by Osage Utility Operating Company, Inc.
3. This order is effective when issued.
