ORDER FURTHER EXTENDING TIME TO FILE STAFF RECOMMENDATION

On June 13, 2019, Union Electric Company d/b/a Ameren Missouri filed an Application and Request for Waiver, requesting that the Commission authorize it to sell an electric transformer to SSM HEALTH, INC. d/b/a SSM Health Saint Louis University Hospital. Because SSM Health is planning construction involving the transformer, Ameren Missouri asked the Commission for expedited approval of the transfer.

In an effort to comply with Ameren Missouri's request for expedited consideration, the Commission directed its Staff to file a recommendation by July 3, and later extended that due date; first until July 23, and then until August 2. On July 31, Ameren Missouri filed a motion explaining it will be filing an amended application to correct certain errors identified by Staff. Ameren Missouri asks that Staff be allowed until August 13 to file its recommendation. The motion represents that Staff does not oppose the request for additional time.

The Commission will grant Staff additional time to file its recommendation.

THE COMMISSION ORDERS THAT:

- 1. Staff shall file a recommendation regarding Ameren Missouri's Application and Request for Waiver no later than August 13, 2019.
- 2. Any other party wishing to file a recommendation regarding Ameren Missouri's Application and Request for Waiver, or that wishes to respond to Staff's recommendation, shall do so no later than two business days after Staff files its recommendation.
 - 3. This order shall be effective when issued.
