# ORDER CANCELING HEARING AND REMAINING PROCEDURAL SCHEDULE

On May 15, 2019, Union Electric Company d/b/a Ameren Missouri filed an application with the Missouri Public Service Commission seeking a Certificate of Convenience and Necessity (CCN) to construct, own, and operate a wind generation facility in Atchison County, Missouri. A procedural schedule was adopted and set an evidentiary hearing for August 26 to August 29, and required the parties to make other filings before and after the hearing. On July 31, multiple parties in this case submitted a Stipulation and Agreement, purporting to resolve all issues, except those raised by Western Missouri & Kansas Laborers District Council. On August 7, Western Missouri & Kansas Laborers District Council filed a notice of withdrawal as an intervening party to the case.

The Commission, based on the representation of counsel made in the Stipulation and Agreement, understands that no other party is requesting a hearing. Therefore, the Commission will cancel the above referenced evidentiary hearing, as well as the remainder of the procedural schedule.

## THE COMMISSION ORDERS THAT:

- 1. The remaining procedural schedule, including the hearing scheduled for August 26 to August 29, 2019, is canceled.
  - 2. This order shall be effective when issued.
