ORDER APPROVING COMPLIANCE TARIFF

Effective Date: August 24, 2019

On July 25, 2019, Union Electric Company d/b/a Ameren Missouri filed a tariff that will permit some of its electric customers to choose a due date that would alter their billing cycles. The Commission previously granted Ameren Missouri a waiver from certain Commission rules to allow for the filing of this tariff. The tariff, which purports to comply with the Commission's order, carries an August 24 effective date.

In response to Ameren Missouri's tariff filing, the Commission directed its Staff to file a recommendation by August 8. The Commission also allowed any other party wishing to file a recommendation until August 8 to do so.

Staff filed its recommendation regarding Ameren Missouri's compliance tariff on August 6. Staff advises that the tariff complies with the Commission's order and recommends the Commission approve that tariff. No other party filed a recommendation.

The Commission has reviewed the proposed tariff and Staff's recommendation. The Commission concludes the submitted compliance tariff is consistent with the Commission's prior order and will approve it to become effective on and after August 24.

THE COMMISSION ORDERS THAT:

1. The proposed tariff submitted under Tariff No. YE-2020-0014 by Union Electric Company d/b/a Ameren Missouri on July 25, 2019, as substituted, is approved, effective on and after August 24, 2019.
2. This order shall become effective on August 24, 2019.
3. This file shall be closed on August 25, 2019.
