### ORDER ESTABLISHING TIME TO RESPOND TO STAFF'S RECOMMENDATION AND PROPOSED CONDITIONS

On July 5, 2019, Union Electric Company d/b/a Ameren Missouri submitted an application requesting authority to issue and sell up to \$350,000,000 aggregate principal amount of additional long-term indebtedness. On August 8, 2019, the Staff of the Missouri Public Service Commission submitted a recommendation advising the Commission to approve the financing request with conditions.

The Commission will direct Ameren Missouri to file a response indicating whether it accepts Staff's proposed conditions. The Commission will also establish a time for any other party to file a response.

### THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri shall file a response to Staff's recommendation no later than August 14, 2019.

2. Any other party wishing to respond to Staff's recommendation shall do so no later than August 14, 2019.

3. This order shall be effective when issued.
