ORDER DIRECTING RECOMMENDATION ON REVISED TARIFF

On December 13, 2023, the Commission issued its *Report and Order Approving Addendum to Territorial Agreement* in this matter. Among other things, that order directed Union Electric Company d/b/a Ameren Missouri to submit revised tariff sheets by January 24, 2024, to reflect the change in its certificated electric service area in Audrain County resulting from the order.

On January 12, 2024, Ameren Missouri filed a tariff sheet purporting to be in compliance with the terms of the Commission’s December 13th order. The new tariff sheet bears an effective date of February 11, 2024, and has been assigned Tracking No. JE-2024-0100.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted tariff sheet complies with the Commission’s December 13th order.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Spire's revised tariff sheet (Tracking No. JE-2024-0100) no later than January 29, 2024.
2. This order shall be effective when issued.
