On January 18, 2024, the Office of the Public Counsel (OPC) filed its *Office of the Public Counsel's Motion for the Commission to Order Evergy Missouri Metro and Evergy Missouri West to Comply with Commission Rule 20 CSR 4240-2.135* (Motion).
