On December 15, 2021, Union Electric Company d/b/a Ameren Missouri was granted authority to sell approximately 1.5 miles of 161 kV electric transmission line to the Wabash Valley Power Association (Wabash Valley). On January 5, 2024, Ameren Missouri filed a notice that the transaction had been completed on October 17, 2023. Ameren Missouri also filed a revised tariff sheet (Tracking No. JE-2024-0097) amending its service territory by deleting from its tariff the transmission line that was sold.

The Commission has reviewed the changes to the relevant tariff sheet and will approve the tariff change to take effect on February 4, 2024.

Ameren Missouri also filed a tax impact statement in accordance with the Commission's order which is attached to this order. To provide notice in compliance with Section 393.190, RSMo, the Commission shall direct its Data Center to serve a copy of this order and the attachment on the County Clerk of Cape Girardeau County, Missouri.

THE COMMISSION ORDERS THAT:

1. Revised tariff sheet, Tracking No. JE-2024-0097, is approved to become effective on February 4, 2024.
