On December 20, 2023, the Commission directed its Staff (Staff) to provide more information about a noncompliant well agreement that a Missouri Department of Natural Resources (DNR) witness stated had been drafted and was under DNR internal review.

On January 8, 2024, Staff filed a status report indicating that on December 28, 2023, DNR issued a *Notice and Order to Abate Violations and Pay Administrative Penalties* concerning the Misty Mountain Public Water System. That Order became effective on December 28, 2023. Staff attached a copy of the order to its status report.

The Commission will set a deadline for any objections to the Commission admitting the *Notice and Order to Abate Violations and Pay Administrative Penalties* into the record of this case for consideration by the Commission.

## THE COMMISSION ORDERS THAT:

1. Any party wishing to object to the admission of *Notice and Order to Abate Violations and Pay Administrative Penalties* as a Commission exhibit shall do so no later than January 30, 2024.
