## ORDER CONSOLIDATING FILES

On November 7, 2023, Trevor King filed an application with the Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) to Osage Valley Electric Cooperative ("Osage Valley"). On November 13, 2024, and December 1, 2024, Matthew Gibreal and Tyler Watts, respectively, each also filed an application with the Commission requesting a change of electric supplier from EMW to Osage Valley. The Commission assigned the three applications the file numbers referenced above.

EMW and Osage Valley have filed their responses to the applications in the three files. In filings made in File No. EO-2024-0166 on December 28, 2023, and in File No. EO-2024-0161 on January 2, 2024, the Staff of the Commission (Staff) suggested that

the Commission consider consolidating the three files, as they have common subject matter and issues and that new construction is in progress on each of the three lots, which are either contiguous or closely proximate to each other.

In each of the three files, the Commission set a January 16, 2024, deadline for any party to object to the consolidation of the three files. No parties responded.

Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of pending actions involving related questions of law or fact. Given that the three files involve related questions of fact, and the request is unopposed, the Commission will consolidate the three files.

## THE COMMISSION ORDERS THAT:

1. File No. EO-2024-0161, File No. EO-2024-0166, and File No. EO-2024-0181 are consolidated, with File No. EO-2024-0161 being the lead file number.

2. The pending orders directing Staff to file a recommendation on each application in each of the files is modified to direct Staff to file a single recommendation encompassing all three applications.

3. This order is effective when issued.
