ORDER RECOGNIZING NAME CHANGE

On January 12, 2024, Aristotle Unified Communications LLC advised the Commission that it has changed its name to Aristotle Unified Communications Inc. On January 19, 2024, the Staff of the Commission (Staff) filed a recommendation indicating the company had complied with all statutory and regulatory requirements for changing its name. Staff recommended that the Commission recognize the name change. The Commission will do so.

To allow Aristotle Unified Communications Inc. to implement the name change expediently, the Commission finds it reasonable to allow this order to become effective in less than 30 days.

2. This order shall become effective on February 3, 2024.
