### JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri") and the Staff of the Missouri Public Service Commission (the "Staff"), and for their Joint Motion to Suspend Procedural Schedule, state as follows:

1. Late yesterday, the Company and the Staff reached agreement on the terms of a settlement that resolves all issues in this case. Joint Movants are working to reduce the agreed-upon terms to a formal stipulation and agreement for filing with the Commission over the next few business days.

2. Under the adopted Procedural Schedule, the List of Issues, List of Witnesses, and

Order of Cross-Examination are due tomorrow. Given the settlement, Joint Movants do not expect a contested hearing will be necessary to resolve this case, which obviates the need for such a filing and later procedural milestones called for by the Procedural Schedule.

3. Consequently, Joint Movants request that the Commission promptly issue an order suspending the Procedural Schedule and similarly, suspending the requirements of yesterday's *Order Regarding Motion to Compel* as moot.

**WHEREFORE**, the Joint Movants respectfully request that the Commission issue an order that (a) suspends the Procedural Schedule, and (b) suspends any obligation on the part of the Company or Staff to comply with the Commission's January 24, 2024, *Order Regarding Motion to Compel.*
