**ORDER GRANTING MOTION FOR EXTENSION OF TIME AND
ORDER GRANTING MOTION FOR LEAVE TO FILE OUT OF TIME**

On November 1, 2010, the Missouri Retailers Association (“MRA”) filed a Motion for Extension of Time in the above-captioned files. MRA stated that its witness has obtained information he would like to use in his testimony. However, MRA believes that information is subject to a protective order by the Kansas Corporation Commission (“KCC”). MRA has thus far been unable to secure permission from the KCC to use that information in this case; as a result, MRA asked for an extension of time, from November 10 to November 17, to file its testimony. Indeed, MRA filed its testimony on November 17, with an accompanying Motion for Leave to File Out of Time.

KCP&L objected on November 8, stating that MRA has had ample time to file its testimony. Further, KCP&L states that it would be prejudiced by the Commission granting MRA additional time, as that would cut into KCP&L’s time to file rebuttal testimony. In the alternative, KCP&L points out that if the Commission grants MRA’s motion, then the Commission should grant KCP&L additional time to file rebuttal testimony, and leave MRA’s deadline to file surrebuttal testimony unchanged.

The Commission will grant MRA's motions, and will grant KCP&L's request for additional time to file rebuttal testimony only in response to MRA's testimony for File No. ER-2010-0355. The procedural schedule is different in File No. ER-2010-0356 and MRA timely filed its testimony in that file. Thus, the motions are denied as moot for that file.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time and the Motion for Leave to File Out of Time filed by the Missouri Retailers Association are granted for File No. ER-2010-0355.
2. Kansas City Power & Light Company may file its rebuttal testimony to Missouri Retailers Association's direct testimony no later than December 15, 2010 in File No. ER-2010-0355.
3. The Motion for Extension of Time and the Motion for Leave to File Out of Time filed by the Missouri Retailers Association are denied as moot for File No. ER-2010-0356.
4. This order shall become effective upon issuance.
