ORDER SETTING A PREHEARING CONFERENCE

On October 13, 2023,¹ Liberty Utilities (Missouri Water) LLC d/b/a Liberty submitted an application requesting authorization to issue long-term debt in the amount up to \$30 million.

On December 21, the Staff of the Commission (Staff) filed its Recommendation which included eight proposed conditions. On January 9, 2024, Liberty responded with an objection to the sixth condition. On January 17, 2024, Staff responded in disagreement with Liberty's objection.

The presiding officer communicated with counsel via email and will schedule the prehearing conference to occur on February 1, 2024, via WebEx.

THE COMMISSION ORDERS THAT:

1. A procedural conference will be held via WebEx on February 1, 2024, beginning at 2:00 p.m. The WebEx details and electronic calendar invite will be emailed to counsel.

2. This order shall be effective when issued.
