On December 13, 2023, the Commission ordered the Staff of the Commission (Staff) to submit a joint proposed procedural schedule.

On January 8, 2024, Complainants filed a *Proposed Scheduling Order* and Staff and Union Electric Company d/b/a Ameren Missouri filed a *Joint Motion to Adopt Procedural Schedule*.

On January 26, 2024, a procedural conference was held in which the parties were directed to collaborate and file a proposed procedural schedule on which all parties agree. The Commission will formalize that direction to the parties and set a deadline.

THE COMMISSION ORDERS THAT:

1. No later than February 15, 2024, Staff shall file, on behalf of all of the parties, a joint proposed procedural schedule.
2. This order shall be effective when issued.
