ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: January 29, 2024

Effective Date: February 11, 2024

On December 13, 2023, the Commission issued its *Report and Order Approving Addendum to Territorial Agreement* in this matter. Among other things, that order directed Union Electric Company d/b/a Ameren Missouri to submit revised tariff sheets by January 24, 2024, to reflect the change in its certificated electric service area in Audrain County resulting from the order.

On January 12, 2024, Ameren Missouri filed a tariff sheet purporting to be in compliance with the terms of the Commission’s December 13th order. The new tariff sheet bears an effective date of February 11, 2024, and has been assigned Tracking No. JE-2024-0100.

At the Commission’s request, the Staff of the Commission reviewed Ameren Missouri’s tariff sheet and, on January 29, 2024, filed its recommendation that the Commission approve the tariff sheet.

Upon reviewing the pleadings, the Commission finds Ameren Missouri’s proposed revised tariff sheet complies with the Commission’s Order and will approve it. To enable

the tariff sheet to become effective on the date requested by Ameren Missouri, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The revised tariff sheet filed on January 12, 2024, and assigned Tracking No. JE-2024-0100 is approved to become effective February 11, 2024. The approved tariff sheet is as follows:
