**JOINT MOTION TO AMEND EXHIBITS TO APPLICATION FOR APPROVAL OF
A TERRITORIAL AGREEMENT**

COMES NOW, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") and Tri-County Electric Cooperative ("Tri-County"), hereafter referred collectively as "Applicants," by and through their respective counsel, pursuant to 20 CSR 4240-2.080, and respectfully request the Missouri Public Service Commission ("Commission") allow the Applicants to Amend Exhibits A and B to Appendix A. The Applicants respectfully state as follows:

1. The Applicants filed a Joint Request for Waiver and Application for Approval of a Territorial Agreement ("Application") on January 3, 2024. The Application included Attachment 1, Appendices 1 and 2, and Appendix A. Appendix A is the Territorial Agreement between Ameren Missouri and Tri-County that designate boundaries of exclusive electric service areas within Adair County. The Territorial Agreement contains legal descriptions and maps delineating the boundaries of the rural areas in the above-captioned counties to become the exclusive service territories of Ameren Missouri or Tri-County.

2. Exhibits A and B contain a legal description of each company's exclusive service territory. Since the filing of the Territorial Agreement, the Joint Applicants conducted land surveys and amended the Exhibits A and B to reflect the legal description of the exclusive service

territories more accurately. The revised exhibits are included with this filing as Revised Attachment A.

WHEREFORE, Applicants respectfully request that the Public Service Commission of Missouri allow the Joint Applicants to Amend Appendix A with the Revised Exhibits A and B.
