On December 21, 2023, the Commission issued its *Order Approving Acquisition* of Assets and Granting a Certificate of Convenience and Necessity (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity (CCN) regarding Country Life Acres in Jefferson County, Missouri.

On January 29, 2024, Confluence Rivers filed tariff sheets purporting to be in compliance with the Commission's Order. Those tariff sheets were assigned Tracking No. JS-2024-0066 and have a proposed effective date of February 28, 2024.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

#### THE COMMISSION ORDERS THAT:

1. No later than February 12, 2024, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.
