### CORRECTED ORDER DIRECTING STAFF REVIEW

The previous order directed a review and other responses to be due February 12, 2024. As that date is a state holiday, this corrected order corrects the due dates to February 13, 2024.

On December 21, 2023, the Commission issued its *Order Approving Acquisition* of Assets and Granting a Certificate of Convenience and Necessity (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity (CCN) regarding Country Life Acres in Jefferson County, Missouri.

On January 29, 2024, Confluence Rivers filed tariff sheets purporting to be in compliance with the Commission's Order. Those tariff sheets were assigned Tracking No. JS-2024-0066 and have a proposed effective date of February 28, 2024.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

#### THE COMMISSION ORDERS THAT:

1. No later than February 13, 2024, Staff shall file a recommendation as

directed in the body of this order or a statement of when it expects to file its recommendation.

- 2. No other party is required to respond, but any party that wishes to respond to the tariff filings shall do so no later than February 13, 2024.
  - 3. This order shall be effective when issued.
