**ORDER GRANTING DESIGNATION AS  
AN ELIGIBLE TELECOMMUNICATIONS CARRIER**

Issue Date: January 31, 2024

Effective Date: March 1, 2024

On December 14, 2023, IM Telecom, LLC d/b/a Infiniti Mobile requested designation as an Eligible Telecommunications Carrier (ETC) to be eligible to provide Lifeline service. Infiniti Mobile requests ETC designation on a statewide basis for the purpose of receiving federal Lifeline service support.

The Commission issued notice and set a deadline for intervention. No intervention requests were received.

The Staff of the Commission (Staff) conducted an investigation and, on January 19, 2024, filed its recommendation and memorandum. Staff recommended that the Commission approve Infiniti Mobile's request for designation as an eligible telecommunications carriers for the purpose of receiving federal Lifeline support on a statewide basis. Staff stated that Infiniti Mobile met the requirements of Commission Rule 20 CSR 4240-31.016 governing eligible telecommunications carriers.

Under federal authority, the application is within the Commission's jurisdiction to decide.<sup>1</sup> Since no law requires a hearing, this is a non-contested case.<sup>2</sup> Non-contested cases do not require formal proceedings or hearings before the Commission.<sup>3</sup> Consequently, the Commission bases its decision on the verified filings.

Based upon its review of the verified application and Staff's recommendation and memorandum, the Commission finds that Infiniti Mobile has met the requirements for ETC designation.

**THE COMMISSION ORDERS THAT:**

1. Infiniti Mobile's application is granted. Infiniti Mobile is designated as an ETC for the purpose of receiving federal Lifeline support on a statewide basis.
2. This order shall become effective on March 1, 2024.
3. This file shall be closed on March 2, 2024.
